2020 School Hive Auction

As in past years, CCBA has again invited the local schools to paint hive bodys to auction at the Bluegrass Bee School in March. Earlier in the month, eight members met on an unusually warm Saturday at Dadant 's Frankfort Branch to assemble the woodenware

It's Tax Time!

About this time of year, I frequently get asked questions about beekeeping and taxes. Many beekeepers want to know if they can deduct the cost of their bee operation from their taxes. First, if you have 2-3 hives, the easy answer is probably no. you're probably a hobby bee keeper and hobby expenses are not tax deductible. To be a business venture, the IRS would like to see verifiable income over \$1,000. The second consideration is are you trying to make a profit. You should be able to

show a profit from time to time. You will need receipts of expenses, a mileage log for vehicle deductions, and records of income (like a sale log, sales invoices, etc. In addition to deducting costs, you must report income. And while you can report bee income on your taxes as general income (the IRS expects you to report all income from all sources), you can only deduct business expenses using a schedule F or schedule C. If you have other farm income from, as an example, cattle, hay, or crop sale, then you can include your bee income and expenses on your schedule F (Farm). Otherwise, you will use a schedule C (Profit and loss from Business). If you prepare your own taxes using a commercial software, you will need the Home and Business edition.

Leslie Cobb, KY DPH Food Safety Branch, gave a very interesting and informative presentation regarding proper labelling at the meeting and she will also be a presenter at next year's Bluegrass Beekeeping School.
