CCBA Bee Extracts

Swarming is one thing, but removing a colony from structures or trees is quite another undertaking-the other extraction in beekeeping. June was the month that found CCBA members Jim Psiones and Bill Dickerson with opportunities to do both. After receiving a message from Ky Dept. of Fish and Wildlife, Secretary Jan Rafert "Called in the troops", being the keeper of the swarm list for CCBA, and Bill Dickerson went to

investigate and mounted a swarm box at the entrance the colony was using on the outside of the Headquarters building in Frankfort. Liability issues prevented Bill from digging in to the structure. Jim Psiones answered the call to a "bee tree" in Anderson County that was discovered after a limb had broken of during a storm. Jan and Jim both arrived and was able to

<u>"Slingin' Honey"</u> An Article to Help in the Process

It's that time of the year when we've turned our attention and efforts from build up, swarming and catching swarms, making splits, etc., to honey processing—the "reward for our labors". The article at right is very informative and helpful even though we may have done it for years. Published March 2018 in Bee Culture magazine, it is written by Bob Binnie of Blue Ridge Honey Co.



"How good honey is for us, or whether it is any good at all, not only depends on how we use it, but also on how we process and store it.

Program:

Jack Kuhn and Wes Henry did a live Facebook broadcast at 6:00 p.m. in which they inspected our one top-bar and two Langstroth hives. Jack had installed a swarm into the top-bar about a week earlier and therefore wanted to know how it was doing. The entire evening's program is readily available for viewing on our Facebook page.

Meeting:

President Wes Henry called the meeting to order at 7:01 p.m. He called for the approval of the April meeting minutes, as printed in the newsletter. There were no comments, this then taken as an approval. The same held true for the financial report as presented by treasurer, George Fowler.

George also mentioned that he had a couple of checks from Wilson's Nurseries for our members. Wilson's provides shelf space and sells honey from our members only. Members receive at \$7 per pound on consignment.

Activity Reports:

Swarm Report:

Again, this month we received three calls regarding swarms to which members responded. Jack reported that he had caught twelve swarms so far this season and Wes said that he has caught two. Wes also had to split two of his hives to avoid them from swarming.

Library Report:

Librarian George Fowler reported that the library remains secure in his basement awaiting a time when it once can be serviceable.

Old Business:

From the Floor:

A member asked about the use of our extractor and its location. Wes said that the extractor is available to any member for a deposit of \$50, which will be refunded when the extractor is returned clean and in the same condition as it was received. As far as the location, Wes said that another member currently has it, but Wes isn't certain who. He will check and get the two members in contact with each other.

George asked about this year's black locust bloom. Jack Kuhn said that there wasn't one to speak of in Franklin Co. and the surrounding areas due to the unusual weather and intermittent frosts.

Jack also mentioned that he would be contacting Dr. Clare Rittschof regarding the status of her virus study. He encourages our members to contribute to the study, if it is still in process. Once he checks with Dr. Rittschof, he will have an email sent to the membership.
