September's Farmer's Mkt Honey Booth

It was a continued dry day and the jars were arranged and displayed like sober soldiers, stood and glowed in the soft morning sun at the CCBA September Farmer's Market Booth. Three members were present, Wayne Parrish, George Fowler, and Wes Henry to offer local honey for taste

and sell. Folks are always amazed, and this Saturday was no different, that color and tastes vary with local honey, and the question most asked is how, and/or why so? This gives anyone helping with the booth the opportunity to talk with the public on all things bees and honey. However, our response to their questions begin with what the bees are foraging on but includes more specifically, but isn't limited to, the environment in which the plants grow, the season in which they forage, and types of plants. In fact, George had honey extracted from the same hives but six weeks apart and the differences





We wish to promote the many beekeepers in Kentucky that raise their bees, harvest, process their honey, and sell their honey all within the State of Kentucky. All beekeepers within the State of Kentucky are eligible for certification by making formal application to KSBA and paying the appropriate annual dues. The annual dues include membership in KSBA at no extra cost. Each local association will receive \$3 back for each of its members that become certified...As Certified Honey Producers, beekeepers will have agreed to follow the program guidelines and to apply the certified honey label with a registered trade symbol to the bottles of honey that they sell. Honey Booth at Waddy Fall Festival





Business Meeting

Following a very interesting presentation on Varroa mite fall management by Jack Kuhn, Vice President Ken Daniels called the meeting to order at 7:32 p.m. and asked for a motion to accept the minutes of the July meeting as published in the newsletter. Eddie McNutt made the motion, Ralph Davison seconded it, and the members present carried the motion.

Treasurer George Fowler presented the financial report and a motion to approve was requested. Kay Daniels made the motion, Wayne Parrish seconded and the motion was approved.

Committee Reports:

Swarm Committee – the secretary reported that no swarms had been reported within the last month. Swarm season should now be over.

Extractor – Ken reported that Gary Risen used the association's extractor and returned it in good shape.

Library – George mentioned that he brought our library with him and that he intended to ask the Extension Office if they might have a place to hold it, thus saving him the effort of bringing it with him each month.

Outreach – Kay and Ken Daniels gave a Kids Pollinator Class at the Library on August 6th. The said that overall the kids were quite interested in the topic and in receiving information about our association.

Farmers Market – Ken reported that the market has instituted a new "Token Policy". Two tokens that affect us are the "Snap" and the "Debit" Token. The former is a blue token that has \$1 & \$5 values and can be used to purchase – all food and food producing plants, excluding food truck purchases and alcohol. The Debit Token is green, also comes in \$1 & \$5 amounts, can be used to purchase all items and change can be given.

State Fair – Our members did very well. Jack Kuhn won three Blue Ribbons and Dan Ramey & Ken Daniels won two Blue Ribbons. We were also well represented by ten members who volunteered for the two honey booths. Record sales were achieved this year. Thanks to all.

Old Business:

George Fowler reported that our participation in the annual Spellalooza was cancelled on our part due to this being the third year in a row that no preparation for us was provided by the organizers.
